Dear Collier Resident:

Please read the information below. It will help you decide if you want to install a deduct meter.

A Deduct Meter records the amount of water that flows only to the exterior of your house and does not enter the sanitary sewer lines of Collier Township Municipal Authority. If you decide to install a deduct meter, you will be issued an annual refund for the total number of gallons of water recorded that did not enter the sanitary sewer system, less a \$25.00 yearly administrative fee.

A sprinkler system would warrant the use of a deduct meter and in some cases a swimming pool.

The deduct meter would be installed by a plumber of your choice and at your own expense. You may hire any plumber of your choice and the plumber can purchase any type of standard deduct meter, however, the outside remote must be a visual read remote and synchronized with the auxiliary meter inside. It is important that the site where the remote is installed must be clear of bushes, flowers, air conditioning units, etc. for easy access to read. If you have any questions concerning the installation of the deduct meter or if it would be cost effective for you, please call the Collier Township Municipal Authority office at 412-279-4941.

If you choose to install a Deduct Meter or if there is a Deduct Meter previously installed, please fill out the attached Application and return it to:

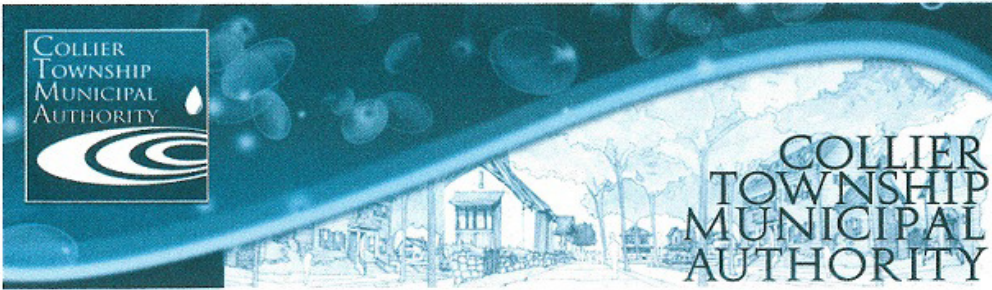

We will forward your application to ALCOSAN. ALCOSAN will then set up an appointment with you to inspect and read your deduct meter.

It is important to remember that you will not be credited for any water registered on the deduct meter until after it is inspected and initially read by ALCOSAN, therefore please do not use the meter until it has been inspected by ALCOSAN. This includes if you purchased a home with a Deduct Meter installed by a previous owner.

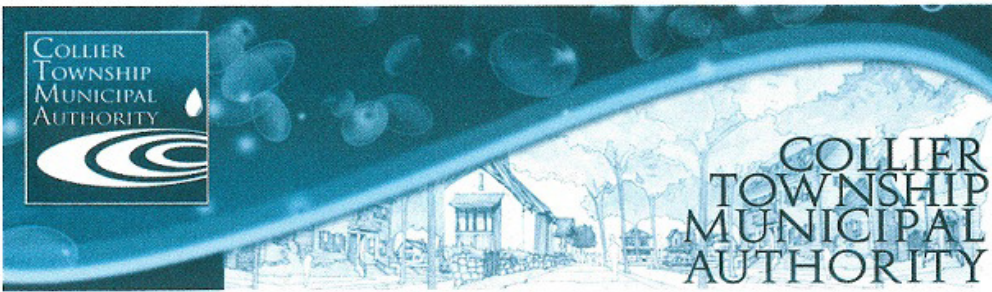

Agreements and representation:

I, the undersigned applicant, do hereby request permission to install a deduct meter with a remote outside meter on my property at my own expense to measure metered water not entering into the sewer lines of the Collier Township Municipal Authority.

I certify that the deduct meter will be installed in such a manner and at such a location so as to measure water that does not and cannot enter the sanitary sewer system and the installation is subject to the approval of ALCOSAN.

I agree to notify the Collier Township Municipal Authority of the installation of the deduct meter and the remote meter, and will arrange a time convenient to the ALCOSAN representative to allow for the examination and inspection of the installation and the approval of same.

I agree and understand that I will not be credited for any water registered on the deduct meter if I use it before it is inspected and initially read by ALCOSAN.

I acknowledge that the Collier Township Municipal Authority will annually notify me to read and submit a photo of the meter and will issue to me a refund for the total number of gallons of water that did not enter the sanitary sewer system, less the \$25.00 administrative fee.

I agree that under no circumstances will any line beyond the deduct meter be connected or reconnected so as to discharge water into the sanitary sewer system. (No threaded bleed off valve.)
