

RESOLUTION NO. 10-11-07-02 (MANCINI/EWING ROAD EXTENSION)

**A RESOLUTION OF THE COLLIER TOWNSHIP MUNICIPAL AUTHORITY
AGREEING TO ACCEPT OWNERSHIP OF SANITARY SEWERS AND MANHOLES
AS INSTALLED AND CONSTRUCTED AND REFERRED TO AS THE MANCINI-
EWING ROAD EXTENSION**

WHEREAS, the property developer, John Mancini has caused to be constructed, certain sanitary sewers, manholes and associated main line components to serve a portion of property owned by the property developer along Ewing Road; and,

WHEREAS, John Mancini has awarded the necessary contracts for the construction and installation of the line and manholes to John Mancini Construction; and,

WHEREAS, field observations of construction of the sanitary sewer lines were performed by NIRA Consulting Engineers, Inc. on behalf of the Collier Township Municipal Authority; and

WHEREAS, NIRA Consulting Engineers, Inc., by letter of August 06, 2007, advised the Collier Township Municipal Authority that final inspection and testing of the sanitary sewer lines of the Mancini/Ewing Road Extension was finally complete; and,

WHEREAS, the sanitary sewer lines and manholes passed the required air and vacuum tests and passed the necessary deflection (mandrel) test; and,

WHEREAS, NIRA Consulting Engineers, Inc. recommended that the sewer lines listed in the attached exhibit sheets be accepted by the Collier Township Municipal Authority; and,

WHEREAS, John Mancini now have provided to the Collier Township Municipal Authority its certification as to the construction cost of the said lines which were constructed at a construction cost of \$71,975.00; and

WHEREAS, John Mancini has or will arranged to post with the Collier Township Municipal Authority a maintenance bond or letter of credit in the amount of fifteen (15%) percent of the construction costs and said bond is for a period of eighteen months from the date of the completion and acceptance of the work and is in the amount of \$10,797.00.

NOW THEREFORE, the Collier Township Municipal Authority at a publicly held meeting on the 11th day of October, 2007.

1. Reviewed this Resolution, and formerly adopted the Resolution, accepting ownership and control of the sanitary sewer lines and manholes listed in the attached exhibit as of August 06, 2007 or the date of receipt of the maintenance bond, which ever is the latest.
2. The lines and manholes hereby accepted are referred to as the Mancini/Ewing Road Extension of Lots, the said system comprising of approximately 504 linear feet of 6" PVC pipe, approximately 125 linear feet of 6" DI pipe, and five (5) manholes located in or near Ewing Road as an Authority sanitary sewer system now and into the future.
3. This Resolution of acceptance of these public improvement, shall be maintained as part of the records of the Collier Township Municipal Authority and a copy shall be delivered to John Mancini and a copy shall be filed with the bonding company, or their agents, who have agreed to the issuance and delivery of said

maintenance bond, as required above, to the Collier Township Municipal Authority.

Adopted this 11th day of October, 2007, by a majority vote of the members of the Collier Township Municipal Authority.
